Part III Line 28: Kinship Navigator Program: Our first goal is to build a foundation of safety for children by meeting the immediate needs of the kinship family. To meet the immediate needs, Foster Kinship provides emergency resources of diapers, food, clothing, car seats, beds, cribs, and referrals to kinship families. In 2016, 421 kinship families were provided with emergency resources, 392 families were linked to long-term community resources, and 71 families received community resource referrals as part of case management. Our second goal is to provide the most permanent home for children by stabilizing the kinship family. Foster Kinship provides expertise and resources to help caregivers establish an appropriate legal relationship to the children and to achieve financial stability. In 2016 46 families were provided assistance with guardianship, 100 with child-only TANF applicaitons, 10 with Medicaid and 12 with SNAP. Our third goal is to create a nurtruing home environment by increasing the caregiver's capacity to meet the well-being needs of children. In 2016 84 families attended support groups, 66 receive back to school support, 178 received a thanksgiving meal, 107 families received christmas gifts, and 9 received theraputic services. Foster Kinship's Kinship Navigator Program served 614 unique families- 550 new and 64 returning from previous years for ongoing supportive services. 5 trained family advocates staffed the Navigator Resource Center Monday-Friday 10 AM-4 PM and answered 1,038 helpline calls ar provided 331 in person consultations. Nearly 1,000 unique children were provided safer, more stable, and more nuturing homes due to Foster Kinship's Navigator Program. In addition, 504 families were provided specialized child welfare training, described below.

Part III Line 29: Kinship Information Sessions and Licensing Classes: Kinship Information sessions are facillitated twice a month for new kinship caregivers involved with the child welfare system. The sessions provide information on the Kinship Care Road Map, the licensing process, child-only TANF, Kinship Navigator Program Services, and community resources. At each session participants are supplied with a Kinship Care Road Map and relevent applications. In 2016 254 families attended one of 24 Information Sessions. Foster Kinship also facilitate the 5-week "Caring for Our Own" Kinship licensing classes so that kinship caregivers caring for children in foster care can become licensed. 420 families completed licensing training and were also connected with the services provided by our Kinship Navigator program. Those attended classes were assisted by a professional facillitator and a kinship caregiver co-lead. Free childcare was provided and children were taught about Lifebooks, dealing with trauma, and remaining connected to parents even when it is not possible to be with them.
