Foster Kinship strengthens kinship caregiver's capacity to provide safe, stable, and nurturing homes to children in Nevada. We offer two free programs for those parenting their relatives in Nevada: a kinship navigator program and a child welfare training program.

Kinship Navigator Program: Our first goal is to create a foundation of safety for children by meeting the immediate needs of the kinship family through community connection. To meet the immediate needs, Foster Kinship provides community referrals, resource identification and location, and emergency resources. In 2018 Foster Kinship provided 1,244 emergency resources, took 847 helpline calls, provided 392 resource locators, and made 703 community referrals. 99% of families met their community connection goals. Our second goal is to provide the most permanent home for children by stabilizing the kinship family both legally and financially. 308 families were provided legal case management and 260 were provided financial case management. 93% of families achieved their legal and financial goals. Our third goal is to create a nurturing home environment for children by increasing their caregiver's capacity to meet well-being needs of traumatized children. 309 families attended support groups, 912 attended family events, 129 participated in parenting course, and Foster Kinship peer advocates made 1,839 support calls. 96% of families met their emotional support goals. Overall in 2018 the Navigator program served 2,360 new children in kinship care. Foster Kinship also received \$11,572 of donated in-kind services for the Navigator program.

Child Welfare Training Program: The child welfare training program serves kinship families who are caring for children in the foster care system. The program provides information sessions, kinship licensing classes, CPR and car seat classes, and QPI trainings to ensure families can provide the most safe, stable, and nurturing home for children in foster care placed with relatives. 358 caregivers attended an information session, 709 caregivers completed the 5-week kinship licensing training, 468 completed CPR, 470 completed car seat safety. All classes are facilitated by Kinship Navigator Family Advocates who provide peer support in addition to their professional experience. Families in the child welfare training program are also connected to the services available in the kinship navigator program. Foster Kinship also received \$4,575 of donated in-kind services for the Child Welfare Program.
