The program provides information sessions, kinship licensing classes, CPR and car seat classes, and QPI training classes to ensure families provide the most safe, stable, and nurturing home for children in foster care placed with relatives or fictive kin.

The Kinship Navigator Program provides statewide information, referral, support, and case management services for anyone raising a relative or fictive kin child in Nevada.
